- Responded to various media requests including a number upon the release of the Coroner's report.
- Meeting held with NZTA's Ernst Zollner regarding the expert panel recommended by the Coroner.
- Attended briefing meeting with NZTA on the One Network Road Classification system.
- Annual fund raising letter sent out to members and supporting organisations.
- Planning for the annual CAN weekend.
- Planning underway for the Cycle Friendly Awards 2014.
- Preparing for the April AGM including getting the accounts audited and filed with DIA Charities.
- Working with a communications consultant on campaigning and messaging.
- Members found for the Addressing Cycling Safety Reference Group and the BikeWise Reference Group.

# **Projects:**

- Continued to work on the Road Safety Trust project in conjunction with BikeNZ, CAN concentrating on the "Road User Workshops and Everyday Cycling Instruction" subproject. A lot of the work has been on networking with trucking companies to spread into that area for road user/cyclist safety workshops of some form.
  - Driver meetings with Toll and Transpower.
  - Meetings with the AA, ACC, Road Transport Forum and the Christchurch Road Safety Forum to disseminate information about the project and to help facilitate working with heavy vehicle road users.
  - o Bus/Cyclist workshops in Dunedin during November.
  - Bus/Cyclist workshops in Auckland in January and in Dunedin during February.
  - NZ Trucking association workshop in Christchurch during February.
  - Presented along with BikeNZ to the non-partisan cycling forum for MP's at Parliament during February.
  - Negotiating with Citibus re more bus/cyclist workshops for Auckland in early 2104.
  - Discussing with National Road Carriers regarding truck workshops.
  - o Preparing updated plan and work schedule for 2014 and 2015.

### Priorities for 2013-2014:

The Committee hopes that the strategy developed during 2013 can be implemented.

There is work that is necessary to meet current commitments; the Road Safety Trust project has targets for each of the three years it runs, so supporting Jena and the people delivering that contract on behalf of CAN is essential.

Policy development in the past year has again been ad hoc rather than proactive due to lack of resources.
